### Two CAC Bi-lingual Family Advocates/Case Managers

The Children's Advocacy Center of Suffolk County (CAC) unites public, private and community partners to promote safety, healing and justice for child victims and their families. The CAC works closely with an array of agencies to coordinate high quality investigations and assessments of alleged abuse; provide support to children and families; offer specialized training for a diverse range of professionals; and to prevent child abuse in our community.

The Bilingual Family Advocates/Case Managers have an integral role at the Children's Advocacy Center of Suffolk County by offering education, support, advocacy and referrals for necessary services in order to help children and families heal after violence and abuse.

THE CAC SEEKS TWO BACHELOR'S LEVEL BILINGUAL FAMILY ADVOCATES/CASE MANAGERS TO SUPPORT CHILDREN AND NON-OFFENDING CAREGIVERS IN CASES OF ALLEGED CHILD SEXUAL ABUSE, PHYSICAL ABUSE AND EXPOSURE TO VIOLENCE. ONE POSITION IS ENGLISH/SPANISH. ADDITIONAL PREFERRED LANGUAGES INCLUDE HAITIAN CREOLE, PORTUGUESE, CAPE VERDEAN CREOLE, AND CHINESE.

\*At this time, the Children's Advocacy Center of Suffolk County has adopted a hybrid model including on-site and remote work.

# **Responsibilities:**

- Outreach to caregivers in cases of child-to-child sexual abuse (and other cases of child abuse) to establish a supportive relationship;
- Provide case management, advocacy, and coordinate support for children and family members
- Utilize the CAC's NCAtrak case management system and ensure appropriate case record documentation
- Receive and respond to referrals regarding children with Problematic Sexual Behaviors and assist with initial screenings
- Offer emotional support, information, and psycho education regarding dynamics of abuse to children and caregivers if needed;
- Assist caregivers in identifying strategies and mechanisms to best support children impacted by violence and abuse and other non-offending family members;
- Assist families in identifying needs and facilitate referrals for services;
- Outreach to mandated reporters and community partners in cases of child-to-child sexual abuse (and other cases of child abuse) to provide consultation and support of children and caregivers;
- Contribute to the CAC multidisciplinary team by assisting non-offending caregivers as a support, liaison and advocate before, during, and after multidisciplinary team meetings;
- Maintain ongoing relationships with all multidisciplinary team members and other involved

agencies, as needed, to ensure a coordinated response to each family's needs and to support maximum utilization of services;

- Attend all staff meetings, case reviews, in-service training and other meetings, as required;
- Other duties, as required.

# **Required Qualifications:**

- High School diploma or GED required. Bachelor's degree preferred in Social Work or Human Services;
- Fluency in Spanish, Haitian Creole, Chinese, Portuguese, or Cape Verdean Creole;
- 1-3 years related work experience with bachelor's degree; Minimum of 2 years of related work experience without a related bachelor's degree;
- Demonstrated ability to provide services in a professional, respectful manner using active listening and problem-solving skills;
- Resourcefulness and ability to multi-task;
- Working knowledge of dynamics of child abuse and neglect, parent-child dynamics and child development essential;
- Strong, effective verbal and written communication skills
- Experience with Microsoft Office Suite including Outlook, Word (required), Excel, and PowerPoint (preferred);
- Passion for CAC mission and commitment to preventing and addressing the impacts of violence and trauma;
- Commitment to understanding how systemic inequality affects child and family safety and well-being.

#### **Desired Qualifications:**

 Working knowledge of MA Department of Children and Families, criminal legal response to child abuse, children's advocacy center and multidisciplinary models, and familiarity with Suffolk County social service, medical, mental health, domestic violence, civil legal and community services/agencies helpful;
